STUDENTS LIKE KAYLIE NEED YOUR HELP

Every year, Wichita State has far more students who apply for financial aid than can be helped with available resources.

For scholarships that are awarded based on financial need, a simple formula is used to determine whether a student meets the criteria. In basic terms, if the student's Expected Family Contribution is less than the annual cost of attendance at Wichita State, then the student qualifies for need-based financial aid.

Wichita State is proud to help every student achieve their dream of getting a college education, regardless of their financial standing. Need-based scholarships are essential to this mission.

NEED-BASED SCHOLARSHIPS: TWO OPTIONS

- The minimum donation to endow a scholarship is \$35,000, which can be spread in equal payments over as many as five consecutive years.
- CURRENT SCHOLARSHIPS: SUPPORT FOR A SPECIFIED PERIOD

 The minimum to establish a current scholarship is \$5,000, which can be spread in equal payments over as many as five consecutive years.
